The Police at Work research was conducted over five years from 2007 to 2011. The Police at Work: The Wave Five Report is the final in the series. The research involved annual interviews initially with 950, and finally around 700, police officers, who were also police union members, from four Australia jurisdictions—New South Wales, Victoria, the Northern Territory and the Australian Federal Police. The work was funded by the Police Federation of Australia and the Police Associations of those four States and Territories to explore the workplace experience of service police officers.
