Message from ICPRA President

"Kia ora all, welcome to this edition of e-news, where we can report on an extremely successful conference in Capetown in June. The conference was hosted by the South African Police Union (SAPU). They provided a wonderful venue and range of speakers and activities which showcased their beautiful country magnificently. A special thank you to Mpho Kwinika and Oscar Skommere, the President and General Secretary, and their team.

The theme of the conference was assisting our less fortunate police colleagues to attain the right to establish democratic associations. Our visitors from Kenya and Mozambique were able to convey to the conference the consequences for police officers of not having a voice. In Kenya, many officers, poorly trained, equipped and supported are being killed in border areas where they operate with little or no support.

Nazario Muauambane, the president of the Mozambique Police Association attended on behalf of OIP/CPLP which is a grouping of Police Unions from Portuguese speaking countries. This group includes representatives from South America, Africa, Asia and Europe. As a result of Nazario's attendance, the conference agreed relationships between the two bodies should be formalised.

Also at the conference, was the Director of the ILO Pretoria, Mr Vic van Vuuren, who outlined a pathway which will best enable ICPRA to assist our colleagues. Monique Marks, an academic in the field of Police Labour relations, also spoke at the conference. We will be continuing to speak with Monique to explore ways in which she can assist ICPRA.

In summary, the conference was extremely successful. The forum was also addressed by Nkosinathi Nhleko MP, Police Minister in the South African Government and J.P. (John Piere) Smith, Mayoral Committee Member for safety and security from the office of the Mayor of Cape Town, which was recognition of the local Police Unions. Delegates left the conference with a determination that ICPRA can fill a void which exists internationally to provide a voice for working police officers.

Also at the conference, I was privileged to have been re-elected as Chair of ICPRA, and Calum Steele was reappointed as secretary.

We look forward to the next conference which is to be hosted by Eurocop in 2016 at a yet to be named venue.'

AGSI Wins Trade Union Rights for Sergeants & Inspectors in Ireland John Redmond, General Secretary of the Association of Garda Sergeants and Inspectors

The Association of Garda Sergeants and Inspectors (AGSI) in Ireland has won a European case, which will see the rules in relation to trade union rights for members of An Garda Síochána being changed. (Initial announcement made on May 17th 2014)

The AGSI who represent 2,000 Sergeants and Inspectors in the Irish police force brought the case in June 2012 through the European Confederation of Police (EuroCOP) against Ireland's implementation of the European Social Charter.

The complaint alleged that it, and other police associations, did not enjoy full trade union rights in Ireland and that Articles 5, the right to organise, Article 6, the right to bargain collectively and Article 21, the right to information and consultation of the European Social Charter were violated as a result.

Strong Case for Tougher Sentencing for Attacks on Officers

The full extent of injuries to officers is coming to light. A local tv company, UTV, obtained shocking figures using a Freedom of Information (FoI) request, and it makes for grim reading. Here's a flavour of what it unearthed:

- In a two-year period (2012-13), there were 6,866 injury and non-injury attacks
- From January to May this year, the figure was 1,050
- The two and a half-year tally by far exceeds the total number of officers in the PSNI
- On average, there are almost ten attacks per day
